Price Changes - China Sec 301 Tariffs - 3<sup>rd</sup> Tranche 25% duty rate

On May 9, 2019 the Office of the United States Trade Representative (USTR) published the Federal Register notice formally announcing the increase in tariff amounts for the third round of Section 301 for products manufactured in China from the 10% tariff to 25% effective with any items received into the country after June 1 provided they left China before May 10th.

We previously communicated in October 2018 these same items when they originally received the 10% tariff. The HTS codes and the corresponding HOSPECO Products that are affected are list below.

As we did with the first 10% tariff we have worked diligently to mitigate the additional 15% increase where we could by negetlating more favorable pricing or changed sourcing to countries other than China where we are able. You will be advised of the specific price changes separately and these changes will be effective with orders placed on or after July 1, 2019. HOSPECO's price impact has varying percentages per category with the majority in the 6-10% range. All contract pricing will be similarly affected as of 7/1/19. There will be no buy-ins allowed since there wash't sufficient notice on these tariff changes to allow for any inventory buildup.

This represents what we know now based on the Harmonized Tariff Codes listed on the 3<sup>rd</sup> tranche that are manufactured in China. What we do not know for sure are those other HOSPECO products that are manufactured from component parts that may also be subject to these tariffs and incorporated into future cost increases that will additionally affect pricing going forward. Further changes could occur as they become known to us:

As has been widely reported, the President has recommended a 25% tariff to the remaining \$300 plus billion dollars of Items imported from China. There are additional HOSPECO Items that will be affected should this be finalized. We will advise when and if this it happens. We have until June 17th to formally comment to the U.S. Trade Representative on those items on the 4th tranche that we feel should be excluded from that list. Once the 4th tranche list is finalized, we will report to you the related price increases. Please know that we cannot give normal price increase lead times due to the nature of these increases.

HOSPECO is making every attempt internally to identify alternate sources of product where applicable and to create operational afficiencies to mitigate further increases and continue to drive value in all of our categories.

We appreciate your support in these uncertain times and will adjust pricing accordingly as circumstances change in the future. Although we are all in unchartered waters, I am optimistic that our economy will continue to grow and withstand any of the headwinds created by these challenges.

Price Changes - China Sec 301 Tariffs - Tranche 4A 15% duty rate

As you probably are aware, on August 30, 2019 the Office of the United States Trade Representative (USTR) published the final determination for Section 301 Tariffs on Tranche 4 commodities. By specific direction of the President, List 4 commodities require additional duties of 15%. The final Tranche 4 list has been divided into 2 parts – 4A and 4B and can be found in the Federal Register.

Those commodities listed on the 4A list were subject to the additional 15% tariff as of 9/1/19 and the commodities listed on the 4B list are subject to the 15% tariff on 12/15/19.

For the record, none of these Tranche 4 products have been previously impacted by any prior tariffs, having said that President Trump announced that all items that previously carried the 25% tariff will increase another 5% to 30% effective 10/15/19.

Attached are the price changes only on the items affected by the 4A list. The price changes are effective with orders placed on or after 11/4/19. No buy-ins will be allowed. All contract pricing will be similarly increased as of that date.

Although we know the items that will effected on the 4B list effective 12/15/19, we are not increasing those prices at this time.

HOSPECO is making every attempt internally to identify alternate sources of product where applicable and to create operational efficiencies to mitigate further increases and continue to drive value in all of our categories.


